LICENSING AND ROYALTY AGREEMENT

1. Licensed Content.

Licensor grants to Licensee, its agents, successors, or assigns, those for whom Licensee is acting, and those acting with its authority and permission, the absolute and right and permission to copyright, use, re-use, publish, and republish, recordings, copies, reproductions, digitally sampled and/or reconstructed versions of Licensor's DVD, CD-ROM, VHS, S-VHS, DV, Mini-DV, SWF, .Fla, Digital Artwork and other Media submission(s), in whole or in part, including but not limited to any and all animation, music, video, narrative shorts, features and trailers, in whatever form submitted (collectively the "Content"), in any advertising, display, or product, including software releases, derivative or ancillary products or works, whether such products or works are now in existence or are hereafter created or acquired. Licensor and Licensee further agree

that such right and permission has been granted to Licensee on an exclusive basis for use in the Software Graphics Market.

The Content may be copyrighted, used and/or published individually or in conjunction with other photography, video works, and recordings, and in any medium (including without limitation, print publications, public broadcast, CD-ROM format) and for any lawful purpose, including without limitation, trade, exhibition, illustration, promotion, publicity, advertising and electronic publication.

3. Waiver of Approval.

Licensor waives any right that Licensor may have to inspect or approve the finished product or products, or any advertising copy or printed matter that may be used in connection with such product, or the use to which it may be applied.

4. Indemnification.

Licensor releases, discharges and agrees to hold harmless, Licensee, its agents, successors or assigns, and all persons acting under its permission or authority, or those for whom it is acting, from any liability by virtue of any distortion, alteration, digitization, reconstruction, or use in composite form, whether intentional or otherwise, that may occur or be produced in the recording and subsequent reconstruction of the Content, or any other subsequent processing thereof, as well as any publication of the resulting materials.

5. Warranties.

Licensor warrants that Licensor is of legal age and has every right to contract in Licensor's own name in this matter. Licensor further warrants that Licensor has the full right and authority to license the properties to
