Common Goods and Services shall mean any Primary Goods and Services provided by both parties, in part or in whole, which are similar in nature to one another.

Duration. The Right of First Refusal between the parties shall be limited to <<Years>> years from the date on this Agreement.

Exceptions shall mean the transactions and transaction types that are exempt from the Right of First Refusal, unless otherwise agreed upon in writing by both parties.

Notice of Acceptance or Refusal of Terms shall mean the period of time that a response shall be required from the other party (“notice of sale”) for the potential business transaction governed by this Agreement.

Limited Time Period to Close Transaction. If the receiving party cannot complete the sale or transaction within <<Days>> days, then other party shall have full rights to pursue the business transaction, as defined in the notice of sale as they see fit.
