ADULT WEB HOSTING ACCEPTABLE USE POLICY ("AUP")

THIS AGREEMENT is made this <<CurrentDay>> day of <<CurrentMonth>>, <<CurrentYear>> by and between <<CustCompany>> (hereafter referred to as "Customer") and <<Company>> (hereafter referred to as "Company").

The purpose of this policy is to set forth an Acceptable Use Policy ("AUP") by which Customer will abide while using, renting, leasing, or otherwise making use of Company goods and services, in addition to setting forth the Company policy concerning Adult Content and Material. By using Company's Web Hosting and Email services, Customer agrees to comply with the following policies and assume responsibility for the compliance of all Customer's Users permitted by Customer to use Company products and services and all Adult Material stored therein.

Definitions

"Adult Material" or "Adult Content" shall mean all forms of communication, including stories, testimonials, editorials or other narrative descriptions, pictures, photographs, drawings, illustrations, cartoons, anime or other images not listed, video or audio recordings, or any executable program or software.

"Underage Users" shall mean all individuals who do not meet the minimum age requirement for viewing Adult Material in their locality or place of residence.

"Restricted Material" shall mean any content in any form that is prohibited from being hosted, displayed or otherwise made available on Company's servers and hosting accounts.
