- 2. Delivery of Web Site/Digital Media. Company will carry out the services in a professional manner and shall use reasonable efforts to deliver to Customer a Web Site in accordance with the Project Description no later than the Commencement Date. Customer acknowledges, however, that this Commencement Date is an estimate, and is not required.
- 3. Ownership Rights. Customer shall own and retain all rights to the content provided by Customer, which includes all text, graphics, animation, audio components, and digital components of the Web Site ("Customer Content"). Company shall own all rights, title, and interest in and to all other elements, materials, data, graphics, and code of the Web Site or Digital Media including all interfaces, navigational devices, menus, menu structures or arrangements, icons, help and other operational instructions, and all other components of any source or object computer code that comprise the Web Site or Digital Media, all literal and non-literal expressions of ideas that operate, cause, create, direct, manipulate, access, or otherwise affect the Web Site content and design elements (the "Company Content"). Customer shall not do anything that may infringe upon or in any way undermine Company's right, title, and interest in the Company Content.
- 4. Compensation. For all of Company's services under this Agreement, Customer shall pay Company one half the Price at the date of this Order and the balance of the Price at the Commencement Date unless otherwise agreed to in writing by the parties, and if not paid Company shall have the right, but not the obligation, to terminate this Agreement and remove the Web Site or Digital Media and retain all rights in the Company Content.
- 5. Limited Warranty and Limitation on Damages. Company warrants the Web Site will conform to the Project Description. If the Web Site does not conform to the Project Description, Company shall be responsible for correcting the Web Site or Digital Media without unreasonable delay, at Company's sole expense and without charge to Customer, to bring the Web Site or Digital Media into conformance with the Project Description. This warranty shall be the exclusive warranty available to the Customer. Company makes no, and Customer hereby waives and disclaims any other warranty, representation, or condition of any kind
